

## **Member Contract for the Nature Pointe Clubhouse Fitness Center Based on ATNM COVID-Safe Practices Issued June 11, 2020**

**This Member Contract is based on COVID-safe gym requirements as stated in the All Together New Mexico (ATNM) COVID-19 safe practices document dated June 11, 2020. Review of this document and a signature of agreement is mandatory for access to and use of the Nature Pointe Clubhouse Fitness Center.**

1. COVID-Safe Practice Leader, Melissa Trudell, is the contact person for questions or concerns on safe practices and is the designated protocol trainer for staff and volunteers.
2. Members must call or text onsite staff to gain entry into the Clubhouse. The phone number is posted on the Fitness Center door and on the Nature Pointe online Calendar. Members must wait in their parked cars until a staff member opens the door for them. In the event that the Fitness Center meets maximum occupancy as allowed by the ATNM document, additional members will be notified via phone or text to wait in their vehicles until space becomes available.
3. Prior to using the Fitness Center each time, trained volunteer staff members and HOA members must complete and sign a Wellness Questionnaire/Contact Tracing Chart and have their contactless temperature recorded by staff. Members must comply with Fitness Center Staff directives. Failure to do so could result in revocation of access privileges and/or closure of the NP Clubhouse Fitness Center.
4. A maximum of 13 individuals may occupy the Fitness Center at one time. 6 feet social distancing must be maintained between all occupants (except members of the same family) at all times.
5. All Staff and HOA Members must wear masks to the Clubhouse. Masks can be removed during active exercise but should be replaced when exercise is completed. Members may opt to bring gloves but the World Health Organization cautions that wearing gloves is not a substitute for frequent proper hand washing.
6. Taped arrows on the floor indicate traffic flow. Please follow the indicated direction as much as reasonable.
7. Members are not permitted to use a piece of equipment that is immediately adjacent to another piece of equipment already in use. Staff will enforce this. The only exception is that members of the same family may use pieces of equipment that are adjacent to one another.
8. Members are required to clean all Fitness Center equipment after each use using the provided disinfectant spray bottles and paper towels. Staff will enforce this. Every two hours (or more frequently) a staff member will clean and disinfect high-touch items such as door handles and the Unisex Bathroom if it was used. The water fountain will be disabled until further notice.
9. Person-to-person contact training such as sparring, grappling, or wrestling of any form is prohibited.
10. Members need to bring their own individual-use fitness equipment such as water bottles, workout mats, yoga blocks, bolsters, belts, straps, gloves, rackets, balls, horse shoes or similar items until this restriction is lifted by ATNM.
11. Members are welcome to enjoy the Clubhouse outside areas but should maintain 6 feet social distance at all times. The remainder of the Clubhouse will remain closed until further notice in order to limit potential exposure to the COVID-19 virus.
12. Any member not following the above said directives will be denied access to the Fitness Center.

By signing this contract, I hereby understand and agree to comply with these COVID-19 Safe Practices, and despite all Nature Pointe HOA (NP) has done to mitigate the potential of COVID-19 contamination,

acknowledge that NP cannot guarantee that the Fitness Center is a COVID-19 free area. I understand I will be using the NP Clubhouse Fitness Center at my own risk of infection and if I do contract COVID-19, I will not sue NP HOA.
